

CVD-XVII/EuroCVD-17 Extended Abstract Instructions

Thank you for submitting an abstract for the upcoming CVD-XVII/EUROCVI-17 in Vienna, October 4th - October 9th, 2009. Both a manuscript and an extended abstract are required for every presentation (both oral and poster). As usual in our CVD Symposium, the proceedings volume will be available at the beginning of the meeting. The proceedings will be published as an issue of ECS Transactions, which has replaced Proceedings of the Electrochemical Society as the official proceedings publication of the Electrochemical Society. Extended abstracts are due by **April 3, 2009**. **Note that you MUST submit an extended abstract to the Electrochemical Society (see instructions below) in order for your paper to be included on meeting schedule!** The full manuscript, also to be submitted via the ECS web site, is due by **May 8, 2009**.

Please adhere to the following guidelines for preparing manuscripts and extended abstracts. Additional instructions are available on the abstract and manuscript submission web pages of the Electrochemical Society.

Language

Papers will be published in American or British English. Please submit carefully written and proofread material.

Extended Abstract Preparation:

Meeting abstracts should explicitly state objectives, new results, and conclusions or significance of the work. Abstracts **must** be properly formatted and no more than **one page in length**. Please use the preformatted two column template located at:

Manuscript Preparation

A few key points and instructions particular to this symposium are given below. General instructions for all ECS Transactions manuscripts are available on the ECS web site at:

A manuscript template is available there. Please follow it carefully.

The manuscripts should be structured as follows:

- Title, authors and affiliation
- Concise Abstract
- Introduction
- (Experimental or Theoretical) Methods
- Results and discussion
- Conclusions

The abstract should not exceed 150 words.

Page Limits

Contributed oral presentations: 8 pages maximum.

Invited or keynote oral presentations: 12 pages maximum.

Poster presentations: oral presentation limits apply. However, given the sometimes-preliminary nature of the work presented in this format, shorter papers are definitely acceptable (2—4 pages).

Figures

All figures must be numbered consecutively with Arabic numerals, identified by a caption, and cited in order within the text. Figures may be incorporated directly into the body of the text, or they may be grouped following the text. They must fit within the margins of the template

Graph and Line Drawings

Size figures so that the readers may easily observe any points on the drawing that are mentioned in the text. Be sure that lines, symbols, and dimensions are heavy and large enough to be legible after size reduction. Generally, symbols and characters should be 1/8" (0.317 cm) high before reduction. Place captions directly below (or next to) the figure.
